Waiver of Tuition and Fees

**SUMMARY OF REGULATION:** This new regulation confirms the University's policy for waiving tuition and fees as set forth in Florida Statutes, such as s. 1009.26, and Florida Board of Governors Regulations, such as BOG Regulation 7.008. This regulation also sets forth that the university, through the president or his designee, may approve waivers that support and enhance the mission of the university.

**FULL TEXT OF THE PROPOSED REGULATION:**

**UCF-9.005 Waiver of Tuition and Fees**

(1) The University of Central Florida (UCF) waives tuition, non-resident tuition, or associated fees for purposes that support and enhance the mission of UCF as authorized and

limited by Board of Governors (BOG) Regulations, Florida Statutes, or UCF Board of Trustees Regulations. UCF will waive tuition and fees in accordance with those waivers required by BOG Regulation 7.008 or Florida Statutes Section 1009.26. UCF may waive tuition and fees in accordance with those waivers authorized but not required by BOG Regulation 7.008 or Florida Statutes Section 1009.26.

(2) Additionally, the President or his designee is authorized to waive tuition, out-of-state fees, and associate fees for purposes that support and enhance the mission of UCF.

(3) UCF shall report the purpose, number, and value of all fee waivers granted annually in a format prescribed by the Board of Governors.
